**November 1, 2007**

### **Call to Order**

### **Approval - Minutes of October 4, 2007 Board Meeting**

The minutes of the October 4, 2007 Board of Transportation Meeting were unanimously approved upon a motion by Board Member Sewell and was seconded by Board Member White.

## Approval - Award of Highway Construction Contracts in the October 16, 2007 Letting

Director of Preconstruction Debbie Barbour reviewed projects advertised in the October 16, 2007 letting, noting on the basis of the low bids received that 10 projects would cover all the work in the letting. After review of the projects, the following actions on award of contracts were taken:

- (1) On Project C201865, 37831, Buncombe County, the Board rejected all bids. Project will be re-advertised.
- (2) Upon a motion by Board Member Lakey, seconded by Board Member Perkins, the vote was unanimous to award the contracts on the remaining highway construction contracts to the respective low bidders.
