Swearing In of New Board Member

Michael Alford of Jacksonville was sworn-in as a Member of the Board of Transportation by Court of Appeals Judge Linda McGee. Mr. Alford will represent the Division 3 area.

Approval - Minutes of January 7, 2010 Board Meeting

Following the recommendation of Calvin Leggett, Manager of the Program Development Branch, a motion was made by Board Member Perkins, which was seconded by Board Member Womble to approve the following:

R-2707, US 74 Shelby Bypass from west of SR 1162 to US 74 near SR 2603 in Cleveland County

In accordance with statutory requirements and NCDOT regulations, public hearings were held to receive comments on the consideration of a Transportation Corridor Official Map for the above referenced project. The complete transcripts of the hearings are on file with the Public Hearing Officer, and the required recording maps have been prepared and are available for review in the Program Development Branch.

Should the Board adopt the “Official Map” for this project, copies will be provided to the Register of Deeds, Tax Offices, and planning and building inspections offices in the appropriate counties so that the future right-of-way can be protected from development activity.

Additional Business

Approval – Dismissal of Standing Resolution

Upon a recommendation from the Finance and Programming Committee a motion was made by Board Member Perkins, which was seconded by Board Member White to approve the following action:

The Finance and Programming Committee recommends the dismissal of a resolution adopted by the Board of Transportation on June 7, 2007, titled: **Not Transferring Property Interest in Mitigation Sites to the EEP.**

The resolution to be dismissed states that, “NCDOT shall not transfer any property or property interest in NCDOT mitigation sites to the Ecosystem Enhancement Program (EEP) or any other agencies.”

Dismissal of this resolution will allow NCDOT to transfer its mitigation properties to an appropriate third party steward who can manage the sites to preserve their future mitigation value, in perpetuity.

Approval – Resolution for John W. Brown

Upon a recommendation from the Road Naming Committee a motion was made by Board Member Halsey, which was seconded by Board Member Burrell to approve the following resolution:

WHEREAS, John W. Brown was born in Wilkes County on September 12, 1918 and died on November 20, 2008; and

WHEREAS, John W. Brown became a farmer, raising cattle and poultry and tobacco in Wilkes County; and

WHEREAS, John W. Brown served with honor and distinction as a member of the North Carolina House of Representatives for 13 terms between 1971 and ending in 2000. He served six years as chair of the Committee on Agriculture and served on various other committees including Finance, State Government, Transportation and Wildlife Resources; and

WHEREAS, John W. Brown had many accomplishments including his success in helping establish the School of Veterinary Science at North Carolina State University; securing funding

for a cattle arena in Iredell County; securing funding for a special aircraft to fight forest fires and in getting additional roads built in the western portion of the State; and

WHEREAS, John W. Brown was named Man of the Year in North Carolina Agriculture; Man of the Year in North Carolina Poultry and received a lifetime achievement award as Friend of Agriculture and Agriculture Business; and

WHEREAS, John W. Brown proudly served his country as a member of the United States Army from 1944 to 1946, serving in the Engineer Corps during World War II; and

WHEREAS, the Wilkes County Board of Commissioners requested the North Carolina Department of Transportation honor John W. Brown for his selfless service and contributions to the community.

NOW, THEREFORE, BE IT RESOLVED:

That the North Carolina Board of Transportation dedicates U.S. 268 from S.R. 2303 (Clingman Road) to the Surry County line in Wilkes County, as the **John W. Brown Highway**.

That appropriate signs be erected at a suitable time.

WHEREAS, Patrolman A.J. Hedgepeth was killed in the line of duty on October 23, 1931 on West Church Street (U.S. 74 Business) in the city of Laurinburg while pursuing a speeding motorist; and

WHEREAS, the North Carolina State Highway Patrol and the city of Laurinburg requested the North Carolina Department of Transportation honor the memory of Patrolman A.J. Hedgepeth

as a worthy example for all citizens of the city of Laurinburg and Scotland County as a reminder of the ultimate sacrifice he made.

NOW, THEREFORE, BE IT RESOLVED:

That the North Carolina Board of Transportation name the dual bridges at the U. S. 74 Bypass over U.S. 15/401 in the city of Laurinburg in Scotland County, as the ***Patrolman A.J. Hedgepeth Bridge***.

WHEREAS, Ty Burnette began serving the citizens of Andrews in May 1949 as an alderman and selected as mayor pro tem by his fellow members and served the town until May 1957; and

WHEREAS, Ty Burnette was later elected Mayor of Andrews in May 1971 and served in this capacity as the chief elected officer for Andrews until November 1985; and

WHEREAS, Ty Burnette had many accomplishments during the time he served the people of Andrews, which included Andrews Recreation Park upgrades; Dan Holland Impoundment and water treatment plant construction; construction of the Community Services/Fire Department Building; construction of the Andrews Public Library; renovation of the town hall constructed in

1940; and many improvements and upgrades to the water and sewer collection lines of the town; and

WHEREAS, the Cherokee County Board of Commissioners and Town of Andrews requested the North Carolina Department of Transportation honor Ty Burnette for his years of dedication and tireless service to the community.

NOW, THEREFORE, BE IT RESOLVED:

That the North Carolina Board of Transportation name Bridge Number 141 located on State Road 1388 over the Valley River in Cherokee County, as the ***Ty Burnette Bridge***.

That appropriate signs be erected at a suitable time.

Approval – Resolution for Dr. Calvin Jones

Upon a recommendation from the Road Naming Committee a motion was made by Board Member Watts, which was seconded by Board Member Collier to approve the following resolution:

WHEREAS, Dr. Calvin Jones was a North Carolina physician and part of the group of founders of the North Carolina Medical Society; and

WHEREAS, Dr. Jones served as a trustee of the University of North Carolina from 1802 until 1832; elected to the North Carolina House of Commons in 1799 & 1802 and was the mayor of Raleigh; and

WHEREAS, Dr. Jones was owner of a 615-acre plantation in northern Wake County where most of the Town of Wake Forest sits today. He became the postmaster for the area in 1823 and began heading his correspondence as coming from “Wake Forest”. In 1832, the North Carolina

Baptist Convention purchased the plantation and it became the home of Wake Forest College in 1834, which was the first institution of higher learning in Wake County; and

WHEREAS, in February 1834, the college opened to young men having 72 students enrolled by the end of the first year. The first classes were held in the Dr. Calvin Jones House, which also served as the home of the first college president. Shortly after the end of World War II, the college moved to Winston-Salem; and

WHEREAS, the Southern Baptist Convention located its new seminary, Southeastern Baptist Theological Seminary, and shared the campus with the college until it moved in 1956. The Dr. Calvin Jones House was then donated by the Southeastern Baptist Theological Seminary to the Wake Forest College Birthplace Society and moved to North Main Street. Restored to its original appearance, the house was opened in 1979 as a museum; and

WHEREAS, the Town of Wake Forest requested the North Carolina Department of Transportation honor Dr. Calvin Jones for his many contributions to his community and state.

NOW, THEREFORE, BE IT RESOLVED:

That the North Carolina Board of Transportation dedicate the N.C. 98 Bypass in the town limits of Wake Forest as the ***Dr. Calvin Jones Highway***.

That appropriate signs be erected at a suitable time.

Chairman's Comments

As you have or will quickly learn, service on this Board comes with considerable personal expense, frequent inconvenience, questions about our actions and motivations and occasional blame for outcomes that we had no prior knowledge of or input about. This is part of the consequences we receive for service on what many believe is the most prestigious and influential Board in our state. Others no doubt have a different view.

We owe it to the citizens we serve, to our state and to ourselves to accept and exercise the authority and responsibility placed on us by the law and the oath we took when we were appointed to never become simply a rubber stamp for whatever is placed before us. We must do all we reasonably can to educate ourselves about the issues and policies before us and ask tough and hard questions about things we don't understand, have questions about or disagree with. We must bring some degree of common sense and practicality to the temptations of a one size fits all approach that too often is viewed as the only resolution of many issues.


Gene and Jim told you yesterday about the approach we have discussed as a part of the transportation reform to assist our Board in being more effective and efficient in carrying out our legal obligations and responsibilities. We are all in accord that a better planned meeting and organizational structure is a desirable goal and that occasional Board meetings across the state would have educational, informational and public relations benefits for the Board and the Department. We will be pursuing those over the next several meetings with perhaps some experimenting to see what really works best.

Again I urge you as they did yesterday to give us the benefit of any suggestions you have or thoughts about ways we might explore to better fulfill our duties and responsibilities. We have some very difficult challenges in this economy in fulfilling our goals of providing the best means we can of moving people and cargo about our state safely, efficiently and in an environmentally friendly manner. It will take our best efforts and those of the entire department to attempt to reach those goals.
