Board of Transportation Meeting

November 6, 2014

Call to Order

Chairman Curran called the meeting of the Board of Transportation to order at 8:33 a.m. Thursday, November 6, 2014 in Raleigh, North Carolina with the following members present:

Board Member Collett was absent.

Invocation

The invocation was offered by Board Member Sheehan.

Ethics Statement

Chairman Curran read the Ethics Statement advising any Board Member that may have a conflict of interest or appearance of conflict to abstain from participation in that particular item and to file the proper paper work with the Secretary to the Board.

Approval – Minutes of the October 2, 2014 Board Meeting

The minutes of the October 2, 2014 Board of Transportation meeting were unanimously approved upon a motion by Board Member Overholt, seconded by Board Member McQueary.

Secretary's Remarks

Secretary Tata welcomed everyone to Raleigh. The Secretary asked Trey Silver and Cody Hyatt to come forward to be recognized. Mr. Silver and Mr. Hyatt are drivers with the Incident Management Assistance Patrol (IMAP) in Division 14. On August 6 a call was received by the Haywood County Emergency Operations Center with a reported cardiac arrest in the apartments near their location. The gentlemen arrived on the scene of the reported cardiac arrest and performed CPR until emergency responders arrived. The paramedics said the patient wouldn't have survived without their quick response. Secretary Tata presented Mr. Silver and Mr. Hyatt with the "Extra Mile" Award on behalf of the Department for their heroic actions.

Over the past month, Secretary Tata has travelled around the state holding town hall meetings to share the 25-Year Vision, Strategic Transportation Investments, and funding reform, as well as participating in other events. He thanked the Board members and division engineers who have continued to play an integral role in coordinating and supporting these efforts.

Secretary Tata announced that the Draft State Transportation Improvement Program will be released in December. The Department has a concurrent continuous improvement effort as we look at the criteria that were used in the past STIP. By law, the criteria must be updated every two years. Don Volker and the working group are refining the process for the next round of prioritization, known as P4.0. The working group is tasked with looking at improvements that are needed to strengthen the current process. Some of the criteria that may need some adjustments are seasonal instead of annual traffic counts; expanding the current requirements that projects must touch the property line of a transportation terminal to receive points to include projects that are in close proximity; economic competitiveness; incentive for local entities to provide more contribution; emergency evacuation routes; and gaps or missing links in projects.

Secretary Tata noted that the Department has two special events coming up. He shared that March 2015 marks the Department's 100th anniversary. Through the employees, you can see the pride in the organization and this is a cause for celebration.

In November 2014, the Department will be hosting the 2014 American Association of State Highway and Transportation Officials (AASHTO) annual meeting in Charlotte. This is the first time North Carolina has hosted this meeting. North Carolina is looking forward to welcoming our counterparts from across the nation to Charlotte.

SCHEDULE III – GENERAL MAINTENANCE RESERVE

General Maintenance Reserve Formula reconciles Division assessed needs and non-assessed needs with the Statewide assessed and non-assessed needs. Beginning in 1999, the General Assembly has provided additional maintenance dollars to help address maintenance needs identified by the Department’s Maintenance Condition Assessment Program.

The staff recommends all available funds, totaling \$18,865,632, be distributed to Primary Snow & Ice to in order to compensate for the FY 2014 overdraft as a result of an unusually severe winter.

Further detail regarding recommended allocations of these funds is addressed in Table 1 below.
