Virgin Hyperloop One is a new mode of transportation that will move people and supply chain needs through a low-pressure tube at speeds up to 600 miles an hour or more.

Housed within the North Carolina Department of Transportation, the Office of HBCU Outreach has been in existence for more than 20 years and continues its charge “to create inclusion and opportunities for historically black colleges and universities and minority-serving institutions (HBCUs/MSIs) in the transportation industry”. The 10-week summer internship is one of the Office’s signature programs. This program hires more than 40 college students from North Carolina’s HBCUs/MSI. These students work and train in the Department’s headquarters, DMV and its 14 divisions across the state.

“This internship program is multifaceted,” said Chief Deputy Secretary David Howard. *“Students gain professional work experience, exposure to the world of transportation and access to transportation career opportunities that make them far more competitive in the workforce. The Office of HBCU Outreach makes advances with*

diversity and inclusion, in addition to gaining the ingenuity and innovation from this tech-savvy generation.”

HBCU Outreach Director Receives MLK Spirit Award


In January, in front of almost 2,000 attendees, our own NCDOT HBCU Outreach Director Al Austin received the MLK Spirit Award at the 26th Annual McCrorey YMCA Prayer Breakfast in Charlotte. The MLK Spirit Award was established to recognize individuals and organizations in the Charlotte community who have made and are making significant contributions to furthering Dr. King's non-violent approach to transforming racial, economic and social injustices.

Alvin "Al" Austin, former Executive Director of McCrorey YMCA, former Development Officer at Johnson C. Smith University and current Historically Black Colleges and Universities Outreach Director for the North Carolina Department of Transportation embodies the spirit, leadership qualities and heart of Dr. King.

In his professional roles, Al has displayed phenomenal leadership skills and determination as he works to move vulnerable populations off the fringes so that they might reach social, political and economic mobility.

He has always placed "people" at the heart of any mission or job that he undertakes, whether working tirelessly to make programs accessible to families when he was at the Y or ensuring a professional path for graduates of HBCUs or even "adopting" three children in the northwest corridor, helping them with their homework, making sure they had funds to attend school functions and providing them with a daily hot meal, Al has a heart for others. Dr. King once said "*There comes a time when one must take a position that is neither safe nor politic nor popular, but he must take it because his conscience tells him it is right.*" We have seen and felt the positions of impact that litter Al Austin's path. North Carolina's HBCUs Playing a Key Role as NCDOT Announces Grants for University Research Projects to Improve Transportation



The N.C. Department of Transportation has selected research programs at three public universities to each receive \$1 million grants to study future transportation challenges in N.C. and develop ways to improve safety and mobility.

North Carolina State University, North Carolina A&T State University and the University of North Carolina at Chapel Hill will spearhead the multi-university research initiatives over the next three years. These new three-year research programs will begin in early 2020.

The research initiative is known as the University Transportation Centers of Excellence. The three universities leading the research will work with transportation experts at Appalachian State University, North Carolina Central University, the University of North Carolina at Charlotte, Duke University and Fayetteville State University.

“Disruptive technologies will reshape the transportation industry,” said State Transportation Secretary Jim Trogdon. *“This research will provide North Carolina with data we need to prepare for these changes.”*

Much of the research will focus on new technology, which is changing the transportation industry significantly. As North Carolina’s population grows, more people are converting to electric, autonomous and other fuel-efficient vehicles. That means that transportation’s main source of funding – the motor fuels tax – is not sustainable.

“North Carolina is uniquely positioned to perform research on transportation technology and enable the progress and improvement of transportation systems while improving on the mobility and safety of our citizens,” said David Howard, Chief Deputy Secretary for the N.C. Department of Transportation. *“This research should lead to North Carolina having competitive advantages in a global economy.”*
