**Total Motor Fuel Taxes**

Current period revenue increased by \$6.0 million over the same period, prior FY. SI 2020-91 changed the MFT split between the HF and HTF from 81/19 to 80/20 for FY22.

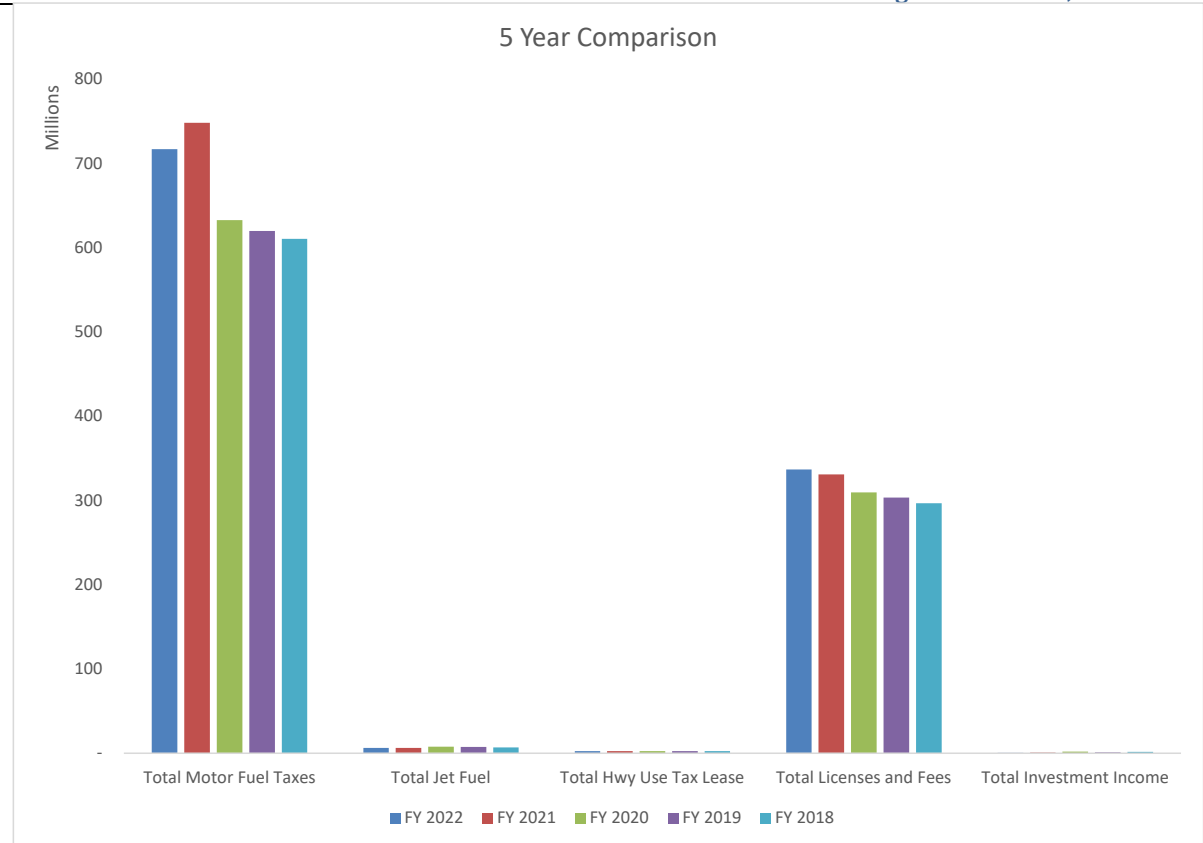
Due to COVID-19, the Department of Revenue allowed late the Motor Fuel filings by businesses for Fiscal Year 2020 so DOT received \$76m in July 2020 of collections that would have been made in April, May and June of 2020.

**Total Licenses and Fees**

Licenses and Fees increased from last year in November by 3.9%.

**Total Investment Income**

The interest rate for November 2021 was 0.15305% compared to November 2020 at 0.44996%

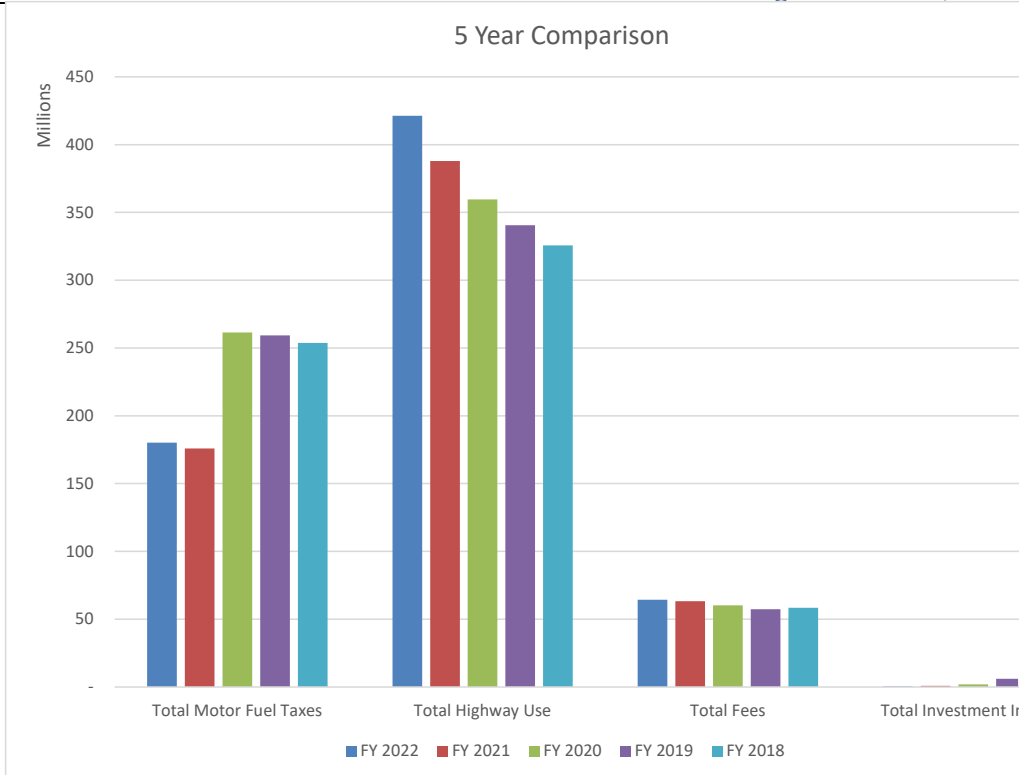
**Total Highway Use**
