## Reporting Periods

---

**Previous Month:** The most recently completed calendar month. Figures are updated during the current calendar month after system processes have closed the previous month's transactions to accommodate for reversal or backed-out entries. Transactions are generally settled by the 10th of each month and aligned with payment to License Plate Agencies for the prior month of service.

**Fiscal Year to Date:** The sum of 'Previous Month' periods within the current July-1 through June-30 state fiscal year. Figures are updated following the same cycle as 'Previous Month'.

**Duplicate – In Office:** The total duplicate plate and sticker issuances at a state-managed or License Plate Agency branch office.

**Duplicate – Online:** The total duplicate plate and sticker issuances via online transactions.

**Issued – First Time:** The total first-time original license, permit, and identification cards issued at a DMV office, regardless of type.

**Renewed – In Office:** The total renewed license, permit, and identification cards issued at a DMV office, regardless of type.

**Renewed – Online:** The total renewed license, permit, and identification cards issued via online transactions, regardless of type.

**Duplicate – In Office:** The total duplicate license, permit, and identification cards issued at a DMV office, regardless of type.

**Duplicate – Online:** The total duplicate license, permit, and identification cards issued via online transactions, regardless of type.

**Previous Month:** The total workforce personnel allocated to the Division of Motor Vehicles for administrative and operational staffing, as approved by the Office of State Human Resources and the Department of Transportation.
