




## Public Transportation Division

### Strategic Plan Update

The Public Transportation Strategic Plan has started. The technical committee met on March 14 to craft themes for the plan and set a framework for the upcoming public outreach efforts. Public Involvement is a major part of the plan.



Six public and stakeholder activities form the basis for the Plan's public involvement:

- **Project Committees** – The Technical and Executive Committees will conduct a total of 10 meetings to build partnerships and shape the messages and recommendations.
- **Community Meetings** – There will be seven geographic and two statewide communities (Land Use and Technology) during May and October 2017 to solicit feedback and support from the transit industry and key stakeholders.
- **Stakeholder Interviews** – Forty stakeholder interviews are planned to give key decision makers the occasion to share their views about the opportunities for enhanced transit service and the benefits that will accrue to North Carolina's citizens.
- **Web-based Public Involvement** – A project web-page will be hosted by NCDOT to enable participants across the state to learn about the Strategic Plan and contribute their ideas. Using MetroQuest, an online dialogue will be conducted encouraging transit customers and citizens from urban and rural communities to share their ideas for improved transit.
- **Videos** – Two three-to-five minute videos are planned including to show how investment in transit can yield a better quality of life for all of North Carolina's citizens.
- **Public Transportation Strategic Plan Conference** – During the spring of 2018, the Project will conclude with a conference that will share the Plan's recommendations with the state leadership and key decision makers.






**Trips in Millions**




**Miles in Millions**






Trips in Millions




Miles in Millions




Hours in Thousands






Trips in Millions



Miles in Millions




Hours in Millions



#### Trips By Funding Type




#### Efficiency By Mode
