This form is to be used by service members who are currently licensed and who are or were employed within 1 year immediately preceding date of application in a military position requiring the operation of a military motor vehicle equivalent to a Commercial Motor Vehicle to request a waiver of the Commercial Driver's License (CDL) Skills and/or Knowledge Tests when applying for a CDL. The application applies to the issuance of an **initial CDL only** and cannot be used for upgrades or restriction changes.
