ADOPT-A-HIGHWAY PROGRAM RENEWAL AGREEMENT

The North Carolina Department of Transportation and _____
(name of business, organization or individual) recognize the need and desirability of litter-free and visually-improved highways.

The Adopt-A-Highway program has been established for community civic organizations as well as private businesses and industry to contribute toward the effort of maintaining cleaner and more beautiful roadsides.

As indicated by their signatures on the back of this agreement, the individual participants of the named entity are aware of the nature of the work which is to be performed and have agreed to follow the department's rules, policies, safety guidelines and instructions. If the above-named entity enters into a contract with a business, organization or individual to clean the entity's adopted section of highway ("a contract service"), the contract service agrees that it is aware of the nature of the work which is to be performed and has agreed to follow the department's rules, policies, safety guidelines and instructions. The individual participants agree to not hold the department responsible for any injuries they, their employees or their agents may suffer or damages that they, their employees, or their agents may cause or suffer as a result of participation in the program and have agreed that signs bearing the group's name shall be installed solely at the discretion of the department.

If the above-named entity enters into a contract with a business, organization or individual to clean its adopted section of highway, it agrees to notify the Director of the Office of Beautification Programs of the North Carolina Department of Transportation in writing within ten calendar days of agreement with contract source and acknowledges that failure to notify the Director of such action may result in termination of the agreement.

This renewal agreement shall be valid for four years beginning _____, 20____, and ending _____, 20____.

The above-named entity volunteers to continue to pick up litter **once every three months** (or more if necessary) for four years along its section of highway and promote a better environment in the community. The entity may cancel this agreement upon 30 days written notice to the North Carolina Department of Transportation.
