Call to Order

Approval - Minutes of April 6, 2006 Board Meeting

The minutes of the April 6, 2006 Board of Transportation Meeting were unanimously approved upon a motion by Board Member Kindley and was seconded by Board Member Thornburg.

Approval - Award of Highway Construction Contracts in the April 18, 2006 Letting

Director of Preconstruction Debbie Barbour reviewed projects advertised in the April 18, 2006 letting, noting on the basis of the low bids received that 10 projects would cover all the work in the letting. After review of the projects, the following actions on award of contracts were taken:

- (1) On Project C201593, Hyde County, B-3348, B-3349, the Engineer's Estimate was changed to \$4,843,373.61. The project was awarded to the low bidder.
- (2) On Project C201576, Randolph County, the Engineer's Estimate was changed to \$2,100,074.00. The project was awarded to the low bidder.

(3) Upon a motion by Board Member Betts, seconded by Board Member Cowell, the vote was unanimous to award the contracts on the remaining highway construction contracts to the respective low bidders.

Award of all contracts covering the use of Federal-aid highway funds is subject to concurrence by the Federal Highway Administration.

Community Transportation Program

The Community Transportation Program (CTP) is designed to enhance the provision of human service and rural general public transportation in North Carolina. The CTP is consistent with the Department of Transportation's goal to develop an efficient, effective, safe, reliable and convenient rural public transportation program that affords all North Carolinians with mobility choices and the opportunity to improve their quality of life. To achieve this goal, administrative funds will be provided to each community transportation system across the state to manage these services.

Federal Transit Administration Section 5311 Nonurbanized Area Formula Program Funds, matched with state and local funds, will be used to fund the CTP administrative, capital, operating (small urban fixed routes and regional transit systems only) and employee development costs of many community transportation systems that meet the requirements of CTP. The department is the designated agency in the state to administer Section 5311 funds.

Agreement and Grant Contract Overview: To formalize the State’s commitment for its share of the cost of the Charlotte South Corridor and the Triangle Transit Authority’s (TTA) Regional Rail projects, State legislation provided for a **State Full Funding Grant Agreement (FFGA)**. The State FFGA describes the project to be funded, identifies the schedule for the project to be completed, and sets the maximum State funding available for the project. The State FFGA, however, is not the mechanism under which State funds are obligated and disbursed for the State share of a project cost. For that, the State FFGA identifies a Grant Contract as the method. Amendments to the State FFGA require approval by the North Carolina Board of Transportation (NCBOT) and a legislative review.

To obligate and disburse State funds for a project a modified standard grant contract was created and titled **Grant Contract**. The grant contract provides for the obligation and disbursement of specific State funds for specific items of a project to the grantee and the conditions under which the funds are disbursed to the grantee, such as receipt of a vendor’s or contractor’s invoice for FTA approved project costs. The Grant Contract refers to a State FFGA setting the overall conditions for State participation in a project and recognizes that the State share of a project cost

is likely to be made available in stages that are related to the approval of the portions of the project by the federal government over time. The State funds in the Grant Contract are not match to any federal grant, but are made available on a separate schedule for the project as a whole. Amendments to the Grant Contract must be approved by the NCBOT.

At this time the Department has executed a State FFGA with the Triangle Transit Authority for the Regional Rail Phase I project. The Board of Transportation adopted a resolution on October 7, 2004, authorizing the department to execute a grant contract with TTA in the amount of \$14,966,473 for project elements that had been approved by the FTA.

Requested Board Actions: The request is for two (2) actions for the TTA project.

- 1) Amend the State FFGA with the **Triangle Transit Authority** for the Regional Rail project to adjust the project description to fit the current project scope of a 12 station, 28 mile project and to adjust the revenue operation date of the service.

The project has been rescope and the authority decided to proceed with the Initial Operating Segment (IOS) only (a 12 station, 28 mile project) instead of the original 16 station, 35 mile project. The 4 stations and 7 miles postponed from the IOS phase of the project will be completed later in a second phase sometime after the first phase is completed.

- 2) Approve an amendment to the Grant contract with the Triangle Transit Authority for the Regional Rail Phase 1 Project to allow for the State reimbursement of a share of the costs of items of the project that have received FTA approval for work to proceed. The authority has received additional FTA grants for continued work on final design and for real estate lease costs. The cost of the items is \$47,817,915 with a State share of \$12,864,965. This amendment will increase the total costs that have been approved by the FTA to \$126,358,807, of which \$27,831,438 are state funds.

Although the Grant Contract Budget will identify all of the costs for the IOS, only those project costs for which federal approval to proceed and Board of Transportation approval of the State match has been granted will be identified as eligible for reimbursement in the Grant Contract. To date, the authority has approval from both the Federal Transit Administration and the Board for the purchase of right-of-way and real estate, and for completion of Final Design work.

As Federal Transit Administration approvals are provided for additional work elements to proceed, the Board will be asked to approve the addition of that work in the Grant Contract, along with the appropriate State match.

Elkin – Relocate railroad switching yard in downtown area. Bridge #338 was closed permanently on December 21, 2005. This bridge carried traffic over downtown area, railroad tracks and the Yadkin River. With Bridge #338 closed, all traffic between the Town's of Elkin and Jonesville must now use US 21 Business which has an at-grade crossing with the railroad tracks. Due to closing of Bridge #338 and all traffic now using US 21 Business and due to the switching operations of the railroad, the traffic is delayed four times daily with traffic backing up a considerable distance in both directions due to the railroad blocking all at-grade crossings while stopped to switch cars. By relocating the switching yard the trains will be able to go through the downtown area without stopping and cause only minimal delay to traffic.

Additional Business

Approval - Resolution for Strengthening North Carolina's Safety Belt Law

Upon a recommendation of the Safety and Emerging Issues Committee, a motion was made by Board Member Blount and seconded by Board Member White to approve the following:

WHEREAS, in 2005, there were 222,047 reported motor vehicle collisions on North Carolina's highways that resulted in 1,469 fatalities and 123,520 persons injured;

WHEREAS, North Carolina's safety belt use rate is currently at 86.7%;

WHEREAS, unbelted occupants still accounted for 525 or 46% of all motor vehicle related fatalities in 2005;

WHEREAS, in 2005, 106 backseat occupants in North Carolina were fatally injured and of those, 71 were unrestrained;


WHEREAS, studies indicate that a person who is unrestrained is ten (10) times more likely to suffer a Class A or severe injury and twenty (20) times more likely to suffer a fatal injury when compared with people who are belted;

WHEREAS, statistics also indicate that a restrained front seat passenger is five times more likely to be fatally injured if the back seat occupants are unrestrained;

WHEREAS, North Carolina motorists who refuse to fasten their safety belts have continued to drive up the cost of the crash tax (crash cost per person) to over \$1,100 per person in North Carolina;

WHEREAS, strengthening current North Carolina safety belt laws is consistent with the mission of the Department of Transportation Board; now, therefore, be it

RESOLVED, that the Department of Transportation Board unanimously and strongly supports revising North Carolina General Statute §20-135.2A to include: 1) Mandating safety belt usage for **all** vehicles except those exempted by Federal Standards and 2) Mandating safety belt usage for **all** seating positions in a vehicle.
