**FARMER AFFIDAVIT**

for a farm truck registration plate

## RULES AND REGULATIONS FOR ISSUANCE OF FARM TRUCK REGISTRATION PLATES

- (1) The term "farmer" means any person engaged in the raising, growing and producing of farm products on a farm not less than 10 acres in area and located in North Carolina and who does not engage in the business of buying farm products for resale.
- (2) The term "farm products" means any food crop, livestock, poultry, dairy products, flower bulbs, other nursery products or other agricultural products designed to be used for food purposes. The term also includes cotton, tobacco, logs, bark, pulpwood, tannic acid wood and other forest products grown, produced or processed by the farmer.
- (3) The term "farm supplies" means any supplies which the farmer might transport for use on his farm, or hired workers or employees on his farm transported to or from work without charge.
- (4) The applicant must be a person engaged in the growing, raising and producing of farm products on a farm not less than 10 acres in area and located in North Carolina. This would not confine the applicant to the sole occupation of farming, but the truck or truck-tractor licensed at the farm rate could not be used for any other purpose or in any other occupation in which such person might be engaged.
- (5) Farm truck registration plates shall be issued only for trucks and truck-tractors used exclusively in the transportation of the applicant's farm products, raised and produced on his farm, and farm supplies necessary to the farming operation. The term "his farm" means the farm under his direct management, supervision, control or custody, and does not necessarily mean that title to the land must be actually vested in him. Farm truck registration plates cannot be used on trucks and truck-tractors transporting farm products for a neighbor or any other person, farm products purchased for resale, or products or supplies of any nature hauled for another for compensation.
- (6) The minimum annual fee for any farm truck registration plate shall be \$24.00.
