be returned with the \$250.00 fee for the class. Completed application and fee must be received at least ten days prior to start date. Classes are filled on a first come, first served basis and class size is limited to maximum of twenty students and minimum of six.

To take the driver education instructor course for a renewal credit (one week) the cost of the class is \$125.00. The driver education instructor's will receive forty hours of renewal credits towards their sixty-four credit hour requirement.

The qualifications are as follows:

- Have at least four years' experience as a licensed operator of a motor vehicle.
- Have not been convicted of a felony, or convicted of a misdemeanor involving moral turpitude, in the ten years immediately preceding the date of application.
- Not have had a revocation or suspension of his driver license in the five years immediately preceding the date of application.
- Have graduated from high school or hold a high school equivalency certificate.
- Not have had convictions for moving violations totaling five or more points in the three years preceding the date of application.
