PRIORITY LOADING PASSES: OCRACOKE RESIDENTS
HATTERAS INLET**

REQUIRED TO DETERMINE ELIGIBILITY

Permanent residency proof: Valid driver's license AND a vehicle registration card both with an Ocracoke address.

WHERE IS THE PASS (STICKER) TO BE DISPLAYED?

Stickers will be displayed on the driver's side portion of the windshield. Stickers that are not in this location **WILL NOT** be honored.

REPLACING PRIORITY PASS STICKERS:

If a sticker needs to be replaced, a new application is required. The replaced sticker will be voided, unless related application supports continued validity. Failure to meet notification requirement may hinder future pass issuance.

ALL STICKERS REMAIN THE PROPERTY OF NCDOT – FERRY DIVISION

REVOCAION:

Priority passes are subject to be revoked at any time for inappropriate behavior.
Acts deemed minor may receive only an email notification as warning not to repeat behavior.
Primary method of revocation notification will be email.

PRIORITY LINES:

Lanes will be labeled "PRIORITY" on both sides of Hatteras Inlet or as loading attendant so indicates.

ARRIVAL TIME:

In order to receive priority loading, vehicle must be in line ten minutes prior to next scheduled departure and before loading COMMENCES, with the understanding the first come, first served basis applies. Boarding sequence is at the discretion of the loading attendant and vessel stabilization may take precedent over priority status. *Vehicles exceeding a safe speed approaching or within the stacking lanes are subject to passes being revoked.*

RANDOM VEHICLE/PASSENGER SECURITY SCREENINGS:

Issuance of a priority pass does not exempt vehicle or passenger from random security screenings in compliance with the U.S Coast Guard Maritime Transportation Security Act.

The priority passes are for HATTERAS INLET ONLY
