**FINAL ENVIRONMENTAL IMPACT STATEMENT PUBLISHED FOR GARDEN
PARWAY PROJECT**

RALEIGH —The N.C. Turnpike Authority, in conjunction with the Federal Highway Administration, today released the Final Environmental Impact Statement for the Garden Parkway project. The Final EIS confirms selection of the route's preferred alternative and addresses comments received on the Draft EIS.

Next steps on the project include:

- **FHWA's Record of Decision.** Expected to be issued in early 2011, the ROD signifies final federal approval of the project route and allows the Authority to move forward with construction.
- **Completion of Project Financing.** An investment-grade Traffic and Revenue Study is underway for the project, which provides critical input into its plan of finance. The study is expected to be complete in second quarter 2011. Financial closing on the project is also expected in 2011.
- **Selection of Design-Build Team.** As the environmental planning process nears completion, the Turnpike Authority will move forward with selecting a design-build team for the project. Under the design-build method, design and construction of a project are completed by a single team to help expedite completion and reduce overall costs. The Authority plans to issue a Request for Statements of Qualifications from interested design-build teams in early 2011 and short-list the teams in spring 2011.
- **Project Construction.** The Authority expects to award a contract and begin construction in third quarter 2011, with completion scheduled for late 2015.

The Garden Parkway is a toll road that will run approximately 22 miles from I-485 in Mecklenburg County to I-85 in Gaston County. The current estimated project cost is about \$930 million.
