19A NCAC 02D .0539 is proposed for readoption without substantive changes as follows:

19A NCAC 02D .0539 VEHICLE PHYSICAL DIMENSION LIMITATIONS

September 2020; Governor James Baxter Hunt, Jr.; Rodanthe, in-service effective March 2019;

Avon, in-service effective March 2020; and Salvo, in-service effective August 2020.
