Necessity:

NCDMV is proposing to revise Vehicle Registration, International Registration Plan, Collision Reports/General Services, School Bus and Traffic Safety, Rules and Regulations Governing the Licensing of Commercial Driver Education Schools and Instructors, and Rules and Regulations Governing the Licensing of Commercial Truck Driver Training Schools and Instructors Administrative Code Rules. Some of these Rules have not been updated in more than 30 years.

As part of the Office of Administrative Hearings (OAH) Periodic Review, these Rules were deemed necessary with substantive public interest. The agency is updating these rules with only technical changes to conform with current law, OAH preferred style and format and modern processes and procedures and to comply with session law changes (2 rules). Additional technical changes to a number of other rules are proposed to clarify and update language. No fees or any funds are being added to these rules. Where appropriate and where fees are already listed in statute, they have been removed from these rules.
