## **FINAL PUBLIC NOTICE**

**Project Title(s)**: NC Department of Transportation A: Debris Removal and Disposal

NC Department of Transportation C: Minor Road Repairs and Safety

Notification is hereby given to the public of the intent of the Federal Emergency Management Agency (FEMA) to reimburse North Carolina Department of Transportation for eligible costs incurred to restore and repair publicly-owned facilities serviced under their authority and jurisdiction damaged as a result of:

Hurricane Florence, incident period of September 7-29, 2018, and under the major disaster declaration FEMA-4393-DR-NC, signed by the President on September 14, 2018;

Tropical Storm Michael, incident period of October 10-12, 2018, and under the major disaster declaration FEMA-4412-DR-NC, signed by the President on January 31, 2019;

Hurricane Dorian, incident period of September 1-9, 2019, and under the major disaster declaration FEMA-4465-DR-NC, signed by the President on September 3, 2019.

Severe Storms, Tornadoes, and Flooding, incident period of February 6-19, 2020, and under the major disaster declaration FEMA-4543-DR-NC, signed by the President on May 8, 2020.

The initial disaster-wide Public Notice was published on Thursday, October 25, 2018 for DR-4393 Hurricane Florence; Wednesday, February 6, 2019 for DR-4412 Tropical Storm Michael; Friday, October 18, 2019 for DR-4465 Hurricane Dorian; and Wednesday, May 13, 2020 for Severe Storms, Tornadoes, and Flooding. Comments and other information received were fully evaluated by FEMA along with evaluation of social, economic, environmental, and safety considerations.

Under the National Environmental Policy Act (NEPA), federal actions must be reviewed and evaluated for feasible alternatives and for social, economic, historic, environmental, legal, and safety considerations. Under Executive Order (EO) 11988 and EO 11990, FEMA is required to consider alternatives, and to provide a public notice of any proposed actions in or affecting floodplains or wetlands. EO 12898 also requires FEMA to provide the opportunity for public participation in the planning process and to consider potential impacts to minority and low-income populations. This notice may also fulfill requirements under Section 106 of the National Historic Preservation Act (NHPA).

This notice serves as a cumulative final notice for FEMA's funding action for the projects located within the floodplain. FEMA has determined that the only practicable alternative is to fund the repairs of several roads and linear facilities, already located within the floodplain prior the events.

Funding for the proposed work project (s) will be conditional upon compliance with all applicable federal, tribal, state and local laws, regulations, floodplain standards, permit requirements and conditions. This action complies with the National Flood Insurance Program (NFIP) requirements.

This Final Public Notice concerns activities involving debris removal and disposal, minor repairs to linear transportation facilities and related safety features which may be in the floodplain prior the event and may affect floodplain or wetland areas. FEMA intends to provide public assistance for the restoration to their pre-disaster condition of these facilities already located within floodplain prior the event, with certain measures to minimize the effect of future flooding, other hazards, and accessibility

requirements which may be included in the work. For example, a bridge or culvert restoration may include a larger waterway opening to decrease the risk of future washouts.

For covered actions, this will be the Final Public Notice provided. Other activities and those involving facilities that do not meet the criteria are required to undergo more detailed review, including study of alternate locations. Subsequent Project Specific Final Public Notice(s) regarding such projects will be published if necessary, as more specific information becomes available.

The National Historic Preservation Act requires federal agencies to take into account the effect of their undertakings on historic properties. Such as actions or activities affecting buildings, structures, districts or objects 50 years or older or that affect archeological sites or undisturbed ground will require further review.

In many cases, the applicant may have started facility restoration before federal involvement. Even if the facility must undergo detailed review and analysis of alternate locations, FEMA will fund eligible restoration at the original location if the facility is functionally dependent on its floodplain location, such as bridges and ferry access, or the project facilitates an open space use, or the facility is an integral part of a larger network and is impractical or uneconomical to relocate, such as a road. In such cases, FEMA must also examine the possible effects of not restoring the facility, minimizing floodplain or wetland impacts, and determining an overriding public need for the facility clearly outweighs the Executive Order requirements to avoid the floodplain or wetland, and the site is the only practicable alternative. NC Department of Transportation and local officials will confirm to FEMA that proposed actions comply with all applicable state and local floodplain management and wetland protection requirements.
