## NCDOT TO HOST PUBLIC HEARING JUNE 5 REGARDING THE PROPOSED WIDENING OF U.S. 158 FROM N.C. 34 AT BELCROSS TO N.C. 168 IN CAMDEN AND CURRITUCK COUNTIES

The N.C. Department of Transportation will hold an informal public hearing for the proposed widening of U.S. 158 from N.C. 34 at Belcross in Camden County to N.C. 168 in Currituck County.

The hearing will take place on **Tuesday**, **June 5** at the **Currituck Cooperative Extension Center**, located at **120 Community Way**, in **Barco** from **4 to 7 p.m.** The opportunity to submit written comments and ask questions will be provided throughout the meeting. Comments received will be taken into consideration as the project develops. Interested citizens are encouraged to attend at any time during those hours. Please note there will be no formal presentation.

The purpose of the project is to improve mobility and increase the roadway carrying capacity of U.S. 158 in the project area to support both regional transportation needs and hurricane evacuation.

NCDOT representatives will be available to explain the location and design of the proposed alternative, as well as information about the state-federal relationship, the required right of way and relocation requirements, as well as procedures that will be part of the project during the meeting.
