

**NCDOT TO HOLD PUBLIC HEARING IN NOVEMBER  
ON PROPOSED RULE CHANGES  
TO THE NORTH CAROLINA ADMINISTRATIVE CODE**

The N.C. Department of Transportation will hold a public hearing for 25 proposed rule changes on **November 8** at the **Greenfield Parkway Building – NCDOT Transportation Mobility and Safety Unit - Conference Room 161**, located at **750 N. Greenfield Parkway** in **Garner** from **3– 4:30 p.m.**

This hearing is being held to solicit comments on the proposed changes to Title 19A, of the North Carolina Administrative Code, Chapter 02, Subchapter B, Parts .0143 (19A NCAC 02B.0143), .0145 (19A NCAC 02B.0145), .0202 (19A NCAC 02B.0202), .0208 (19A NCAC 02B.0208), .0240 (19A NCAC 02B.0240), .0316 (19A NCAC 02B.0316), .0432 (19A NCAC 02B .0432), .0433 (19A NCAC 02B.0433), and .0507 (19A NCAC 02B.0507), Chapter 02, Subchapter D, Parts 0102 (19A NCAC 02D .0102), 0104 (19A NCAC 02D .0104), 0408 (19A NCAC 02D .0408), and 0415 (19A NCAC 02D .0415), and Chapter 02, Subchapter E, Parts .0412 (19A NCAC 02E.0412), .0413 (19A NCAC 02E.0413), .0414 (19A NCAC 02E.0414), .0415 (19A NCAC 02E.0415), .0416 (19A NCAC 02E.0416), .0417 (19A NCAC 02E.0417), .0418 (19A NCAC 02E.0418), .0419 (19A NCAC 02E.0419), .0420 (19A NCAC 02E.0420), .0421(19A NCAC 02E.0421), .0422 (19A NCAC 02E.0422), and .1006 (19A NCAC 02E.1006).
