The N.C. Department of Transportation is holding a public meeting for the proposed extension of McKee Road (S.R. 3440) approximately 0.75 miles on new location from Pleasant Plains Road (S.R. 3448) to East John Street (S.R. 1009) at the recently realigned McKee Road (completed as Project U-4713B) in Mecklenburg County. This project is included in NCDOT's State Transportation Improvement Program (STIP) as Project U-4713A.

The purpose of tonight's public meeting is to:

- Provide you with information on the proposed project design,
- Provide an opportunity to discuss the project and the design with the NCDOT Project Team, and
- Obtain your feedback on the proposed design.

This is an open house public meeting, and a formal presentation will not be given. Please review the handout and maps. Project Team members are here to answer your questions and discuss the project!

You are encouraged to provide comments on the proposed project. A comment sheet is included at the end of this handout that may be completed and returned during this meeting, or you may submit it via mail or email by **November 1, 2018**. All comments received will be taken into consideration.

Project Purpose

The purpose of this project is to improve east-west connectivity in the area, improve access to East John Street and Pleasant Plains Road, and promote community interconnectivity by providing an alternative route to the Charlotte Outer Loop (I-485).

Cost Estimate

The current project cost estimates shown below from the 2018-2027 STIP are subject to change.

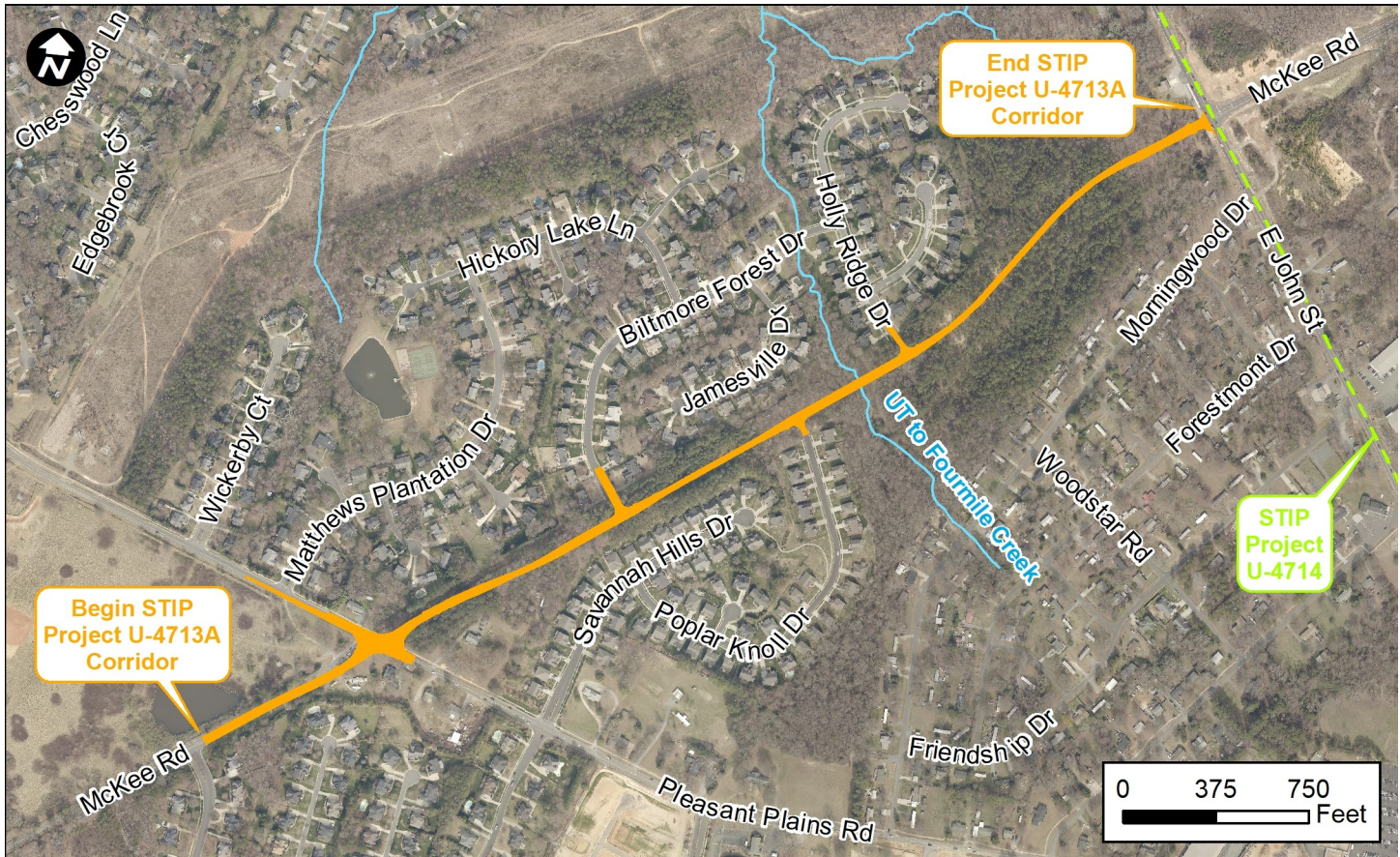
- Utility Relocation: \$500,000
- Right-of-Way: \$2,600,000
- Construction: \$6,100,000
- **Total: \$9,200,000**

The current project schedule shown below from the 2018-2027 STIP is subject to change.

- Environmental Document: Fall 2018
- Right-of-Way Acquisition: Fall 2019
- Construction Let Date: Summer 2020
