

**NCDOT TO HOLD PUBLIC MEETING FOR THE PROPOSED CHESTNUT LANE CONNECTOR (S.R. 1362) FROM MATTHEWS INDIAN TRAIL ROAD (S.R. 1367) TO GRIBBLE ROAD (S.R. 1368) AND GRIBBLE ROAD (S.R. 1368) TO OLD MONROE ROAD (S.R. 1009)
UNION COUNTY**

The N.C. Department of Transportation will hold a public meeting regarding two proposed projects to extend the Chestnut Parkway from Matthews Indian Trail Road (S.R. 1367) to Gribble Road (S.R. 1368) (TIP Project No. U-5808) and Gribble Road (S.R. 1368) to Old Monroe Road (S.R. 1009) (Town of Indian Trail Project).

The purpose of these two proposed projects is to add an alternative route between U.S. 74 (Independence Boulevard) and Old Monroe Road. It will raise the roadway over the active CSX rail line.

The meeting will be held on **Tuesday, February 20th** at the **Indian Trail Elementary School Media Center**, located at **200 Education Drive**, in **Indian Trail** from **5 p.m. to 7 p.m.** The public may attend at any time during the meeting hours. NCDOT representatives will be available to answer questions and receive comments regarding the project. Please note that no formal presentation will be made. The opportunity to submit comments will also be provided at the meeting or via phone, email, or mail no later than March 7, 2018. Comments received will be taken into consideration as the project develops.
