Orange Grove Road Extension in Hillsborough from existing Orange Grove Road (S.R. 1006) to U.S. 70A

STIP Project No. U-5848

Project Description

January 8, 2019

The N.C. Department of Transportation and the Town of Hillsborough propose to extend Orange Grove Road at South Churton Street (S.R. 1009) to U.S. 70A in Hillsborough, Orange County as part of State Transportation Improvement Program (STIP) Project No. U-5848. Three design options were presented at a public meeting in March 2018. Based on input from the public and the Town of Hillsborough, the project team eliminated Alternatives 1 and 3. Changes were made to Alternative 2 based on comments—this new option is referred to as Alternative 4 (see map on page 2).



Alternative 4 uses the same alignment as Alternative 2. The proposed intersection at U.S. 70A was altered so drivers can continue onto the proposed Orange Grove Road Extension in a smooth movement, rather than a sharp turn. This is intended to make the proposed Orange Grove Road Extension the main east-west route between U.S. 70A and South Churton Street.

Purpose of Tonight's Meeting

The purpose of tonight's meeting is to update the community on the project and gather input on the NCDOT recommended option, Alternative 4. The comments received will be considered by the project team as the designs move forward. Project Costs

The estimated projects costs in the STIP are:

Right-of-Way: \$1,067,000
Utility Relocation: \$155,000
Construction: \$4,104,000
Previous Years: \$500,000
Total Projected: \$5,826,000

All costs estimates are preliminary and subject to change.




