#### **PROJECT OVERVIEW**


The North Carolina Department of Transportation (NCDOT) proposes to replace the two bridges over The Straits on Harkers Island Road (SR 1332/1335) that provide access to Harkers Island. Currently, one bridge is fixed-span and one is a swing-span.

## WHAT'S NEW SINCE OUR LAST MEETING?

Since the public meeting in March 2016, NCDOT's project team has been reviewing public comments, bridge design alternatives, and meeting with local government and stakeholder groups. Based on evaluation of the impacts, costs, and benefits of each design alternative, as well as coordination with local, state, and federal environmental agencies, NCDOT is ready to come back to the public with updated information on the four remaining bridge alternatives. In the October 2016 newsletter, NCDOT's project team notified the public that Alternative 1 has been eliminated and a new alternative has been added, Alternative 5.
